

Starlight – Challenge Events 2026/2027 (Excluding London Marathon)

Terms and Conditions

By registering for any Starlight charity place entry into any event in support of Starlight, you confirm you have read, understood, and agree to the following terms and conditions.

Registration and Participation

1. You understand that this Event is not organised by Starlight, but by the Event Organisers, who are solely responsible for the conduct and operation of the Event, including all health and safety requirements. You will read the Event Organiser's Terms and Conditions for the event and comply with any specific Event rules given by them.
2. You will meet the minimum age requirements applicable to the event.
3. By registering for this event, you are confirming that you will:
 - a. Pay the registration fee at the point of registration.
 - b. Complete all online registration requirements with the Event Organiser. Failure to complete the Event Organiser's registration by any applicable deadline given, may result in your place being withdrawn.
4. You acknowledge that you cannot swap, sell, or transfer your place in the Event or allow anyone else to participate on your behalf.
5. You acknowledge that Starlight reserves the right to withdraw your charity place in the Event at any time in exceptional circumstances, including if you do anything that brings, or could bring, Starlight's reputation into disrepute or if you do not comply with these terms and conditions.
6. You will inform Starlight immediately if you are unable to take part in the Event. When your withdrawal is acknowledged by Starlight, you will not be liable to raise any further sponsorship.

Fundraising

7. The registration fee you have paid covers some of the cost, but we like to be completely transparent with our supporters. The cost to Starlight for your place is usually far more than the registration fee, so we have set your minimum fundraising target, to allow us to cover the cost of the place and help us reduce trauma in healthcare for more children than ever.
8. You understand you are expected to raise a Minimum Fundraising Target amount, in aid of Starlight, excluding Gift Aid and Registration Fees. You understand the aim is to raise as much as you can above the Minimum Fundraising Target as possible.
9. You understand that the following fundraising milestones must be met, and failure to do so, could result in your place being withdrawn:
 - a. to fundraise and/or donate 50% of the Minimum Fundraising Target to Starlight by 6 weeks before the Event.
 - b. to raise and/or donate 75% of the Minimum Fundraising Target to Starlight by 2 weeks before the Event.
 - c. to raise and/or donate 100% within 1 month after the Event.
10. You understand that if, at any time, you are unable to demonstrate a commitment to meeting your fundraising target, Starlight may withdraw your place in the Event.
11. You understand that, in addition to reaching out to your networks for support, you may need to organise events to raise funds.
12. You understand that Starlight may ask you to provide an outline of your fundraising plans, and your Starlight Coordinator will contact you regularly throughout your fundraising journey, to support you in your fundraising and training.
13. If at any point you feel unable to raise the Minimum Fundraising Target, you will inform Starlight immediately.

Fundraising Compliance

14. You will use only lawful means to fundraise in aid of Starlight and will not do anything that harms or is likely to harm Starlight's reputation.
15. You will comply with any fundraising guidance or advice issued by Starlight and abide by the Fundraising Regulator's Code of Fundraising Practice available [here](#).
16. You will make clear to everyone supporting your fundraising that you are raising funds 'in aid of' Starlight. Donations and payment terms
17. All monies raised offline, in aid of Starlight, are held on trust for Starlight and you understand that you have a legal responsibility to ensure that all funds raised in connection with the Event are paid to Starlight in a timely manner.
18. You will pay all monies raised in connection to the Event by one of the following means:
 - i. Via an online giving platform (such as, Enthuse or JustGiving).
 - b. Online at www.starlight.org.uk. Please choose "I have raised money from a fundraising activity or event" as your reason for donation.
 - c. To Starlight's bank account by using the banking details provided by Starlight (You understand these will only be made available upon request).
 - d. By cheque, CAF vouchers or Charities Trust vouchers made payable to 'Starlight' and sent to: Starlight, Third Floor, 227 Shepherd's Bush Road, London, W6 7AU.
 - e. By credit or debit card donations made by calling Starlight on 020 7262 2881.
19. You understand that if you withdraw for any reason from the Event any monies raised will be non-refundable and will be treated as a

donation to Starlight, you will advise any sponsors who request a refund to contact Starlight directly to do this.

20. You will make it clear when fundraising in connection with the Event, that the money is not given subject to any conditions and that the funds will not be returned if the Event is cancelled, or if you do not complete the Event.

Your Data

21. You agree to Starlight storing the information that you provided on our database. Please see our [privacy policy](#) for details.
22. You give permission for your personal information to be passed on to the Event Organiser by Starlight for the purposes of the organisation, promotion, and administration of the Event.
23. You give permission for the free use of your name, picture, image, feedback and comments in any future publicity, advertising, fundraising materials, and/or promotion conducted by Starlight.

Health, safety, and fitness

24. You understand that the Event will be physically challenging and there is a risk of injury. You will prepare yourself for the physical challenge of the Event by training, and if necessary, you will seek professional advice to ensure that you are medically fit to participate in the Event.
25. You confirm that you will not participate in the Event if for any reason you are not, or if you feel that you are not, in a fit state to take part and you confirm that it is your responsibility to seek expert medical advice if appropriate.

Liability

26. Nothing in these terms limits any liability which cannot legally be limited, including death or personal injury caused by negligence.

27. You understand that the activities and/or events you organise to raise funds in aid of Starlight are your responsibility, including but not limited, to all costs and liability.
 - a. Starlight bears no liability whatsoever for any events and/or activities you may organise.
 - b. Starlight shall not be liable for any injury, damage or loss to you, your property or to any third party that might occur because of the fundraising activities and/or events that you organise.
28. You understand that you take part in the Event at your own risk, and you will not hold Starlight or any connected persons, responsible for any accident, injury or illness to you, for any damage to your property, or for any losses that might occur as a result of your participation in the Event.
