## **About Starlight**

Starlight is a national children's charity that exists to brighten the lives of seriously ill children and their families. We aim to provide an escape from the reality and routine of serious illness by providing play and distraction services in hospital and hospices; by giving families the opportunity to have fun days out and by granting wishes. Together our services contribute to positive development through childhood even during treatment and hospital stays; and provide families with valuable opportunities to meet a social network of people with shared experience.

The right to play for children is enshrined in the UN Charter for Children's Rights and access to play during serious illness is especially important as a contributor to successful treatment and healthy development. We support health professionals and health play specialists by equipping them with a tool box called a "distraction box" which provides lots of inventive ways to distract children from the unpleasantness of treatment. We also send "boost boxes" to hospitals which are full of toys and activities which help to normalise play in the hospital setting.

Our touring storytellers in the spring and pantomime in the winter often provide children with their first experience of live entertainment and encourage the children to socialise with each other and join in.

Our "Escapes" are a series of events - from a Christmas Party at Downing Street to a summer party at a Children's farm- which give families a day off from treatment, the opportunity to have fun and to make friendships with other families sharing similar experiences all in a safe space, all without the responsibility of organising it for themselves.

We also give families something to plan, to look forward to and to create memories together by granting wishes. Our wishes can meet the needs of children and their families in lots of different ways from a hot tub in the garden that can provide therapeutic support to providing access to opportunities and experiences that they wouldn't otherwise have.

# Our Strategy and the Senior Quantitative Researcher role

It's an exciting time to be joining Starlight as we develop a new strategy to differentiate our services to be more user-centric and with measurable impact. We are establishing an Insight and Children's



Outcomes team which will be carrying out research with seriously ill children, their families and health professionals to better understand the play and distraction needs that can help to contribute to positive development and outcomes even through treatment and hospital stays. As a result of the research we expect to build on our existing services and test and trial new services that are designed to meet very specific unmet needs.

It's an exciting time, but it can be demanding too and so you will need to be a brilliant time and project manager, able to juggle demanding priorities with tight deadlines. You'll need to be self-aware and emotionally intelligent with the ability to build and maintain positive internal and external relationships and you'll have the curiosity and desire to help to establish this new function at the heart of Starlight.

# The main purpose of the role

The Senior Quantitative Researcher is a new role that is integral to embedding this new research function in Starlight. You will primarily be responsible for designing and undertaking quantitative research and you will also develop research proposals and apply for research funding. You'll line manage one researcher.

### **Key Responsibilities**

- Work with the Head of Insights and Outcomes for Children to build Starlight's research and insights function
- Lead, design and undertake quantitative research projects
- Work closely with Children's Services, Wish Granting, Fundraising and Operations to set up, collate and maintain datasets that support and fulfil Starlight's strategic objectives and the generation of insights
- Conduct statistical/data analysis relating to seriously ill children, provisions in this area and Starlight's services
- Conduct literature/evidence reviews of existing research, policies and procedures
- Design and conduct surveys, as well as, data requests with our beneficiaries and key stakeholders, as well as analyse the responses



- Mine and analyse secondary data and complex datasets relating to our beneficiaries and provisions in this area
- Implement mechanisms that track key performance indicators and identify areas to increase efficiency and improve impact
- Monitor, assess and audit the quality of Starlight's data and identify new areas for improvement
- Create infographics and data visualisations to present findings that appeal to different audiences and prepare outputs for internal and external audiences
- Develop research proposals and apply for research funding
- Develop and build relationships with key stakeholders and experts
- Inspire, manage and motivate research staff by setting clear objectives and expected behaviours which are monitored with regular one to ones and performance development reviews

# You'll have:

- A MRes or equivalent specialising in quantitative research and data analysis. A PhD would be desirable.
- Strong quantitative and data analysis research skills
- Experience of successfully developing and conducting surveys and analysis of survey data
- Experience of effective data mining and working with large data sets.
- Experience of using public data, compiling data requests and FOI requests for data
- Experience of writing research funding proposals and successfully securing funding
- Strong understanding of outcome and impact measurement particularly with regard to one or more of the following areas: children, families, health and play
- Strong project management and organisational skills with the ability to plan and deliver efficient and effective solutions



- Excellent report writing and communications skills, both verbal and written; attentive to detail
- Ability to generate different outputs and visualisations that appeal to different audiences
- Advanced CRM & PC skills (Word/Excel/PowerPoint) and proficiency in statistical analysis and data management packages such as R, Tableau, SQL, Excel, etc.
- Ability to work effectively under pressure and manage a high volume of work, delivering to a high standard of quality within tight deadlines
- Diplomatic and confident in building / maintaining effective working relationships with people at all levels
- Hard working, enthusiastic, proactive and a strong team player
- Experience of leading, coordinating and managing research staff and research projects
- Experience of seeking ethical approval for research
